- CCDB's membership consists of lawyers willing to represent low-income and indigent people accused of a crime. Available lawyers are listed on the web-site through the "Find A Lawyer Directory" and must be contacted directly.
- This is an alternative to those not income eligible for representation by the Colorado Public Defender.

- Court appointed lawyers to represent indigent people charged with crimes with jail time penalties only
- No civil work, divorces, landlord/tenant cases or auto accidents (unless crime related)
- Bring proof of income and court documents to appointment
- \$25 application fee
- Other languages are available – translators available upon request.
- To apply for court-appointed counsel, you must fill out the Application for Public Defender/Court Appointed Counsel in a Criminal Case (AKA form JDF208) and submit it in person or via email, fax, or U.S. mail to the appropriate local office of public defenders, listed below.
