- Network activates when overnight temperatures are 32°F or colder and wet, or 20°F or colder and dry.
- Registration may be able to be completed over the phone or online at certain locations, so please call ahead or walk-in to locations. You can also register online at the link above under the 'Get Help' tab. Registration takes about 20 minutes.

- After registering, you will be given the hotline number. Call the hotline each morning to find out if severe weather shelters will be active that night. If so, please call the shelter line or walk-in to one of the listed organizations to be added to that night's roster.
  - Roster is first come, first served.
  - Guests are picked up at warming sites at 7:00PM and dropped off at 7:00AM.
  - A hot evening meal and quick breakfast with coffee are provided.
- Restrictions:
  - Must pass a background check. No violent offenses against persons in the past year.
  - Individuals with disabilities that keep them from sleeping on the floor are ineligible and will be referred out to other shelter options.
  - No ability to house pets.
- Transportation: Bus tickets to support with getting to the shelter are provided at certain sites.

- Community Resources Program
  - Works to connect single adults or couples, without children, to housing options and resources.
  - Services include assistance applying for housing, short-term case management, shelter information, assistance with benefit applications, hygiene products, replacement permanent resident card applications, and advocacy, support, and problem solving in connection with social services agencies.
  - To apply for the program, please come to walk-in hours on Wednesdays 8:00AM-2:00PM.
  - It is helpful, but not required, to bring the following: photo ID, Social Security card, birth certificate, proof of income.
- Project to Assist in the Transition from Homelessness (PATH)
  - Assists adults living with mental illness move from homelessness into permanent housing and access resources to support recovery and maintain housing stability. May be seeking housing as an individual or couple but cannot have dependent children.
  - Case management services: obtaining and maintaining permanent housing, vocational and educational referral, assistance applying for benefits, and advocacy, support, and problem solving in connection with social services agencies.
  - Mental health services: Assessment and evaluation, crisis intervention, behavioral health case management and individual psychotherapy, referrals for mental health and substance use treatment, education and support.
  - To apply, walk-in Monday-Friday beginning at 8:00AM. Please note, they are only able to see the first 6 individuals who arrive each day.
  - It is helpful, but not required, to bring the following: photo ID, Social Security card, birth certificate, proof of income.

- No ID or other documentation required. Need documentation of at least one dose of COVID-19 vaccine.
- Those looking for shelter should call at 10:00AM daily to complete a phone screening. New guests will be required to complete a COVID-19 rapid test upon arrival.
- Beds cannot be held or reserved for future days. Potential guests should call only if they are prepared to arrive that day.

- The STAR Program is a 1-year program that works with individuals and families experiencing homelessness. Each individual of family has their own fully furnished room and bathroom.
- The STAR Program is a fee-based program. At least one adult must have a verifiable minimum income of \$770/month for individuals and \$900/month for families.
- Participants attend monthly case management meetings, attend life-skills and educational workshops, complete random UA/BA testing, and engage in counseling services.
- If you are interested in the program, please stop in for an intake interview Monday-Friday, 10:00AM-11:00AM.
  - Bring the following items to your intake appointment: Photo IDs for all adults, Social Security Cards for all household members, birth certificates for all children, marriage license or common law certificate (for couples), 1 month of pay stubs or proof of other verifiable income.
  - Applications can be accessed online and completed in advance or on-site during intake hours. Background check is required.

  - Offers supportive employment services for women who struggle to maintain a job due to mental health, substance use, and/or criminal history.
- Education
  - Peer specialists and care managers provide individual and group classes that cover substance use disorders, sexual health, mental wellness, financial stability, and more.

- Still Waters Housing is a group of 4 homes providing safe transitional housing for women leaving homelessness, addiction, and the sex industry.
- Each house accepts different populations, so please read the descriptions of each house listed below.
  - *Te Veo House*: immediate, short-term housing to women in crisis. Residents have access to broader services at Open Door Ministries, including job training and life coaching. Women can stay 1 day to 6 months.
  - *Chaya House*: two-year housing program for women coming out of crisis situations or homelessness. Minimum six-month commitment.
  - *Esther House*: two-year transitional housing program for women exiting crisis situations. Sober living environment. Minimum six-month commitment.
  - *Treasure House*: two-year transitional program for pregnant women and women with children under the age of 3 years old. Focus on parenting skills, sobriety, exploring faith, and pursuing education and employment goals. Minimum six-month commitment.
- Two-year programs involve sober living, chores, curfews, counseling, mentoring, employment training, and community responsibilities.
- Two-year program rules:
  - Residents required to attend church, bible study, and community groups.
  - No pets allowed.
  - Random drug tests, breathalyzers, and room checks are administered.
  - No substance use of any kind is allowed. This includes medical marijuana, prescribed benzodiazepines, and prescribed opiates.
  - No individuals with prior sex offenses or violent offenses will be accepted.
  - Cannot accept residents who are currently on parole or probation for crimes against others.
  - Cannot accept residents with current outstanding warrants.

- Transitional housing for women who are considered chronically homeless and who are disabled or have mental health concerns. No maximum length of stay.
  - Chronically homeless is defined as individuals who are homeless for one continuous year or 4 separate times over the course of 3 years.
- Residents are drawn exclusively through the One Home system, so individuals must have a completed VI-SPDAT to be considered for the wait list. The waitlist may be extensive.
- Facility is staffed 24/7 with a Project Manager, Residential Coordinators, Case Managers, and a Part-Time Mental Health Worker/Consultant.

- Community housing option.
- Application criteria:
  - 21 years of age or older
  - Primarily struggle with a mental health diagnosis and be working with a therapist in the community
  - Care for their own needs and either work or attend school for at least 20 hours per week, be able to pay rent (no Section 8 accepted)
  - Attend at least 3 Community Dinners per week and attend Community Meeting every Thursday
  - 90 days of not using alcohol, marijuana, or other substances
  - 90 days abstinence from self-harm behavior, including suicide attempts
- Rent is \$655/month, which includes room and board, utilities, household supplies, six evening meals, social and recreational activities, clinical programming, and 24-hour staff availability. There is a \$200 security deposit with first month's rent.
- Potential residents must first interview with the Program Manager. Potential residents will then be invited to an Applicant Dinner with other residents to determine if they are a good fit for the community.

- Transitional housing for both single women and women with children who are in recovery. Self-run, self-supporting facilities. Residents must be working and cooperate with house rules.
- Mostly single rooms with shared living spaces. Rent is around \$400-\$500 monthly.
- Accepted clients are welcome to live in an Oxford House as long as they stay sober and pay an equal share of house expenses. Average stay of one year, but many clients choose to stay for several years.
- Each house has its own phone number and address.

- In Pet Surrender, they offer compassion and understanding to owners who relinquish their pets and a warm welcome to the animals that are being entrusted to their care.
- Call to schedule an appointment.
- What to bring to the shelter:
  - Pet records – a copy of vaccination and vet records
  - Behavior information – be prepared to discuss your pet's daily habits and behaviors
  - Safe transportation – be sure that dogs are on leashes and cats, or other small animals, are in carriers.
  - DDFL will ask for a \$30 donation to be put toward the cost of your pet's care.
  - If you are disabled and/or don't have transportation to take the pet to the shelter, a Denver resident may contact Denver Animal Protection at 720-913-1311 for assistance regarding an owner's surrender pet.

- Pet surrender program for Jefferson County residents.
  - This is not temporary care, and your pet will be placed for adoption. You must provide proof of residence. Out of county surrenders accepted based on capacity. A higher fee will be charged for out of county surrender.
  - Please bring your pet and their documentation to the office during regular hours. Enter through the "Intake" door.

- You will be asked to sign a waiver releasing ownership, asked about your pet's behavior, and your pet will undergo a behavioral test to determine the best course of action for your pet's placement.
- In-county Surrender Fees: [Dogs and puppies- \$60] [Cats and Kittens- \$40] [Rabbits and ferrets-\$20] [Small mammals-\$25] others vary.
- Out of county surrender fees: [Dogs and puppies- \$120] [Mother dog with litter/pregnant dog- \$160] [Cats and Kittens- \$100] [Mother cat with litter/pregnant cat- \$120] [Others- \$50-\$100]
- Foothills Animal Shelter has partnered with Human Service Agencies and our Animal Control Partners to bring services to the citizens of Jefferson County. Simply put, it is the right thing to do to make lives better for pets and people.
  - PorchLight, A Family Justice Center (FJC)
    - FJC provides comprehensive legal, emotional and critical supportive services for survivors of domestic violence, sexual assault, child abuse, abuse of at-risk individuals, elder abuse, and human trafficking. Located in Lakewood, Colorado, the FJC is a safe, caring environment that provides one-stop services and support. Key local government agencies, law enforcement, community, social and legal service providers, and District Attorney's Offices are located on-site at the FJC to make it easier for victims and survivors to get help. We have an office at the center so we can provide care and resources to the animals belonging to clients of the center.
    - Foothills Animal Shelter provides clients with pet food, animal supplies, vaccinations, and spay/neuter services. We will also provide short-term housing when requested.
  - Colorado Safe Parking Lot Initiative (CSP)
    - CSPI is grassroots, all-volunteer nonprofit organization working to create a statewide network of safe, legal parking locations for individuals and families sheltering in vehicles because they are experiencing homelessness. Safe overnight parking is available for individuals experiencing homelessness and living in a passenger vehicle in Jefferson County's two lots, located in Golden and Arvada. Safe lot guests have access to bathroom facilities, housing navigation and other services.
    - Foothills Animal Shelter provides clients with pet food, animal supplies, vaccinations, and spay/neuter services. We will also provide short-term housing when requested.
  - Protective Custody Program
    - Jefferson County Animal Control and the cities of Lakewood, Arvada, Wheat Ridge, Golden, Edgewater, Sheridan, and Westminster Animal Control Agencies partner with us to provide Protective Custody Services. Our Animal Control Partners pick up and transport animals to Foothills Animal Shelter when the owners have been evicted, hospitalized, died, become homeless, or are experiencing domestic violence and need to flee an unsafe situation.
    - Foothills Animal Shelter provides ten days of boarding services at no charge to families in crisis.
