### Documentation to gather to file taxes:

- Social Security Cards for everyone on the tax return
- Photo ID of taxpayer and spouse (if applicable)
- W-2 forms, 1099s and all other tax related documents for 2022
- 1095 A – if you purchased health insurance through Connect for Health Colorado
- If filing jointly, spouse must be present
- All 2022 tax documents
- A copy of your prior year Federal Tax Return. (May be needed to refer to for prior year filing information.)
- Individual Taxpayer Identification Number (ITIN), if applicable.
- Identity Protection PIN (IP PIN), if the IRS has mailed one to you for identity theft.
- Bank account and routing number for direct deposit (refund) or direct debit (payment).

- Have your taxes prepared for you available to households earning less than \$60,000 in 2022
  - Typically takes 2-3+ weeks
